## WHAT TO EXPECT!!

## **OUR PROJECT**



#### WATER MAIN PROJECT

City of East Point CIP (Capital Improvement Budget) has received 2.5 million dollars of funding from Georgia Environmental Finance Authority (GEFA) to improve the Water Line System here in East Point.



### **PROJECT CONSTRUCTION**

This project consists of the rehabilitation of degraded/undersized water lines throughout the City of East Point. The project will replace 2 to 4 inch water lines with a minimum of 6 to 8 inch water mains and include the installation of new fire hydrants and water valves. The water main replacement work will occur within the EXISTING RIGHT of WAY and EASEMENTS.
