Mr. Rogers discussed an inbound call center project off of Camp Creek but it does not need BIDA funding as it has funding from the State of Georgia. He explained that the industrial moratorium (has now expired) and has caused many projects to not fit into BIDA's criteria as they would have been blocked by the previous moratorium.

Ms. James expressed a desire for adaptive reuse of industrial spaces. The Owen-Illinois site was mentioned as a possibility.

Mr. Rogers said he would provide an update list of available buildings and Brownfield sites.

Following, Mr. Gothard asked about using SBA Loans for the project?

Mr. Glaze spoke about using existing buildings and possibly seeking low interest loans with the Department of Community Affairs.

Mr. Dunson mentioned reaching out to the former owner of the Atlanta Restaurant Exchange to further the idea of a ghost kitchen project.
