Dear Resident/Business Owner,

The City of East Point will be starting construction activities for our **Janice Drive Intersection Improvements Project** on May 27th, 2025, with our awarded contractor **CMC, Inc.** The project is scheduled to be completed and open to the public by **December 21, 2026**, if the construction start date changes new notification letter will be sent out.

Construction Limits

All work for this project will be completed within the City of East Point's Right-of-Way and previously acquired easements. The construction limits of the project will be on both Washington Road and Janice Drive. The following information provides limits of construction.

- **Washington Road** - From St Mark Lutheran Church to 300 feet north of Janice Drive.
- **Janice Drive** - From Pelot Drive to Washington Road

Preliminary activities will include relocation of utilities, surveying and staking, as well as marking of construction layout. Active construction of the project will begin in the following weeks and further communication will be provided.

Project Description

The project will change the current alignment of existing Janice Drive to align with Candlewood Dr SW (Driveway to The Park at Galaway Apartments). Additional project work consists of adding sidewalk, driveway reconstruction, new traffic signal at proposed new intersection (the new Washington Road and Janice Drive), storm water pipe placement, and asphalt milling and resurfacing. The improvements will improve commuter safety and pedestrian visibility. Visuals of project are attached to this notice.

Roadway Closures

Throughout construction, traffic control will be provided to ensure safety for motorists and pedestrians. We do anticipate road closures and lane closures during the duration of this project. Notification will be provided two weeks in advance on the City of East Point Website and to residents within the project area. We encourage commuters to add 5 to 10 minutes to their travel time as traffic will be significantly impacted by construction.

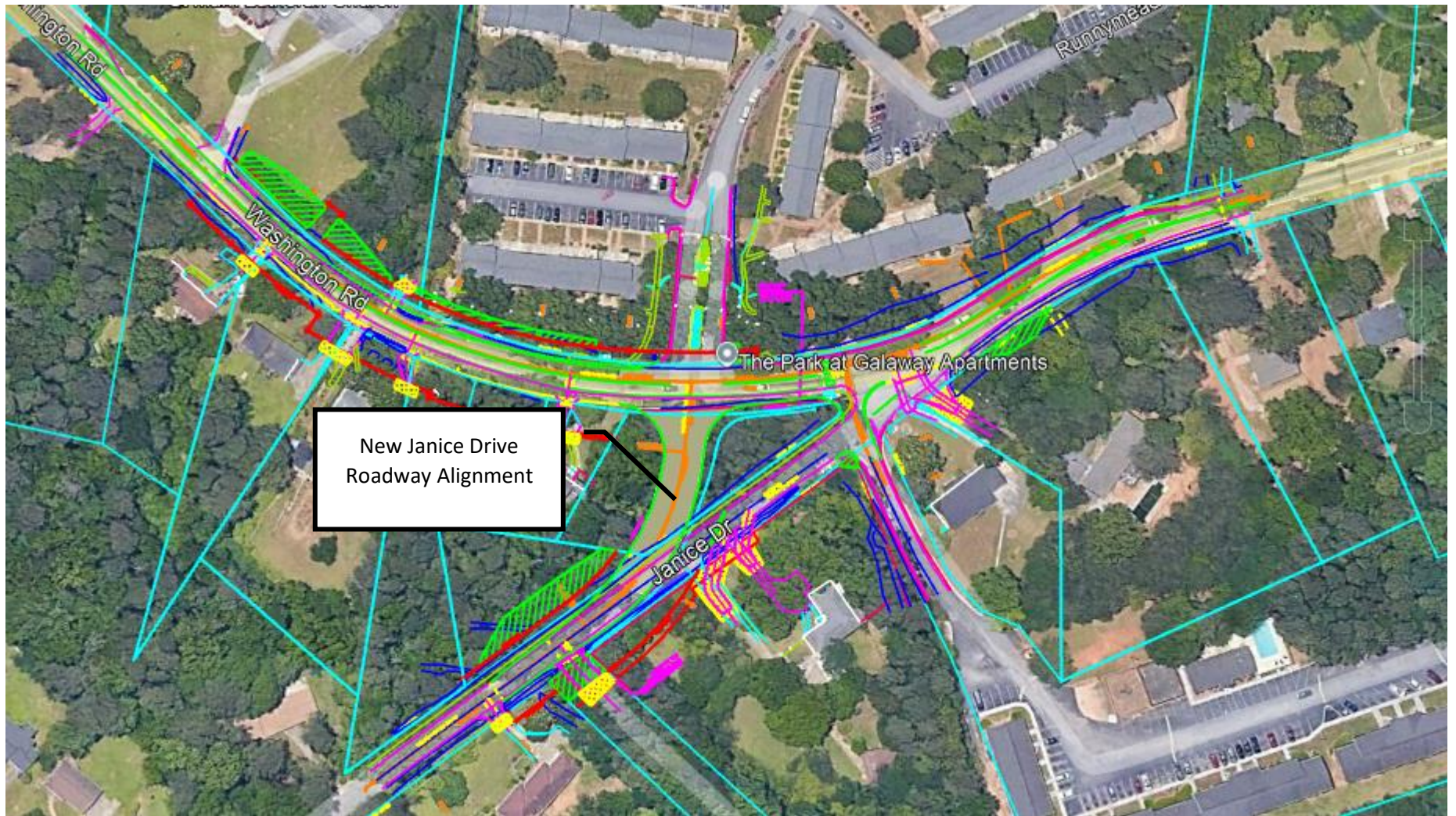
