- 1. GDOT PI #0019796 Street Resurfacing Project (TIP Funding).
  - a. Washington Rd from Main St/SR 14 to N Commerce Dr (Ward D)
  - b. N Commerce Dr from Washington Rd to Redwine Rd (Ward D) COMPLETE
  - c. Centre Pkwy from N Commerce Dr to SR 6/Camp Creek Pkwy (Ward D) **COMPLETE Estimated Completion date: August 2025**

Resurfacing will start at Centre Parkway, beginning at Camp Creek moving towards N
Commerce Drive. Once completed with Centre Parkway, Contractors will start work on N
Commerce Drive from Redwine Road to Washington Road. Construction will end with
Washington Road moving from N Commerce Drive to E Point Street.

# **Transportation Design Projects**

- 1. **Traffic Calming Project Set 2** Study and design consists of milling and resurfacing, sign and pavement marking updates, drainage corrections, and minor traffic calming placement on:
  - Church St (from Washington Rd to Lyle Ave) (Ward B)
  - East Point St (from Washington Rd to Vesta Ave) (Ward B)
  - West Taylor Ave (from Washington Rd to Main St) (Ward A/B)
  - Harrison Rd (from Virginia Ave to Willingham Dr) (Ward B)
     Estimated completion date: September 2025
- 2. **Desert Dr Resurfacing Project** (Ward D) Design includes resurfacing plans for Desert Dr from Camp Creek Pkwy to Redwine Rd. **Complete**
- 3. **Sylvan Rd North Sidewalk Project** (Ward B) The design of the Sylvan Rd Noth project will consist of adding sidewalk from Winburn Drive to the City of Atlanta. **Design Complete**
- 4. Washington Rd and Hammarskjold Dr Intersection Project (Ward D) Design will include the redesign of the Washington Rd and Hammarskjold Dr intersection to include a designated left turn lane for northbound and designated right turn lane for southbound. Estimated completion date: October 2025
- GDOT PI # 0019886 Multimodal Path Tri Cities to Virginia Ave (Ward B) Evaluation Committee Review
- GDOT PI #0017993 Welcome All Rd & Welcome All Rd Connector Study (Ward D) –In design.
   Estimated completion date: February 2026
- 7. **Connally Dr Sidewalk Project** (Ward A) Design includes adding sidewalk to the southside of Connally Dr form Judson Ave to Collins Dr. **Complete**
